We are a hard working group of 18 Haddonfield Memorial High School seniors who together founded Teams Work for Good, Inc. (TW4G) to make a positive difference in our community and beyond. TW4G has a two-fold mission; to help people by engaging in meaningful monthly community service and charitable giving, and to develop our members as leaders. Our success depends on you! If you are not familiar with TW4G, a quick note about who we are. We started TW4G as eighth graders in Haddonfield while playing together for our local club soccer team. We realized that we could take what we had learned on the field – team work and perseverance – and apply it to serving our community and making our world a better place. Since that time we have worked as a team supporting soup kitchens, conducting coat and book drives, raising money to help fight childhood cancer and cystic fibrosis, purchasing food and packing meals to provide relief to people who are hungry, helping to increase access to education and other supports for at risk children and so much more. We have been recognized by the NJ State Legislature with a Resolution for our good work in and around the region.

Since October, TW4G packed 2,500 meals for Feed My Starving Children, organized and hosted our 2nd annual 5K Turkey Trot supporting Kids Alley, Smiles from Kara and the Food Bank of South Jersey. Our philanthropic efforts directed \$20,000 to the Cystic Fibrosis Foundation's Breath of Life Campaign, Pencils of Promise and CASA of Camden. We made over 600 sandwiches on MLK Day helping the Cathedral Kitchen.
